ELIZABETH LEWIS (1827-1828) – DUTTEROW CEMETERY, CLEARCREEK TOWNSHIP

"**Elizabeth Lewis** (July 1827-July 20 1828) is buried in the Dutterow Cemetery and possibly the first to be buried there. She was the daughter (and the youngest of four children) of **William C. Lewis** and **Elizabeth Davis Lewis**. Mother Elizabeth died, quite probably at, or shortly after daughter Elizabeth's birth. Their eldest child was **Edmund Davis Lewis** 1819-1901, my Great Great Grandfather.

"**William C. Lewis** was the second child of **Paul Lewis** and wife **Ann** who removed from Burlington County NJ to near Waynesville Ohio in the very early 1800's. Paul's and Ann's first child was **Rebecca** born December 7 1793 (NJ). In 1815 she married **Jacob Dutterow**. (1792-1860 (or around 1860.)) I have not done much work on the Dutterow family but I hope to establish who Jacob's dad was – maybe it's Philip.

"In 1817 **Jacob** was among the list of petitioners in households in Lebanon regarding the corporation of the town."

WARREN COUNTY "FOOTE" SOLDIERS IN THE CIVIL WAR.

We know of three Foote brothers who served in the Civil War from Warren County: **John Wesley Foote** (1836-1908), **James Harvey Foote** (1841-1914) and **Amos Baldwin Foote Jr.** (1842-1896). They were the sons of **Amos Baldwin Foote Sr.** (1807-1876) and his second wife, **Susanna Livingston** (1815-1844). Their grandparents were **John Wesley Foote** (1766-1851) and **Mary Grigson** (1775-1819). In 1818 the grandparents moved with some of their twelve children from Ohio County, Virginia (now West Virginia) and settled near Zoar in Hamilton Township.

John Wesley Foote (1836-1908) enlisted as a 27-year-old 2nd Lieutenant on 2 May 1864. He was commissioned into Co C, 146th ONG on 2 May 1864 and mustered out at Camp Dennison, Ohio on 7 Sep 1864. In 1857 he was married in Warren County to **Elizabeth Atkinson** (1836-1919). John and Elizabeth are both buried in the West Woodville Cemetery in Harlan Township.

John Wesley Foote filed for an invalid pension in Ohio on 1 Dec 1890 and on 27 Feb 1907 (Application #962481 Certificate #728698) for his service in Co C, 146th ONG

Elizabeth A. Foote filed for widows' pension in Ohio on 22 Oct 1908 (Application #906662 Certificate #667958)

James Harvey Foote (1841-1914) enlisted as a 21-year-old Corporal on 15 Aug 1862. He was mustered into Co. K, 79th Ohio Infantry on 29 Sep 1862 and mustered out at Washington, DC on 9 Jun 1865. In 1866 he was married in Warren County to **Amanda Goodpaster**. James H. Foote filed for an invalid pension on 4 Mar 1896 and on 27 Sep 1911 (Application #1174865 Certificate #954803) for service as a Corporal in Company K, 146th Ohio Infantry Regiment. He died 3 Oct 1914 at Springfield Missouri and is buried in Section 14 Site 1568B at the Springfield (MO) National Cemetery.

Amos Baldwin Foote (1842-1896) enlisted as a 21-year-old Private on 2 May 1864. He was mustered into Co. C. 146th Ohio Infantry Regiment on 2 May 1864 and mustered out at Camp Denison, Ohio on 7 Sep 1864. In 1868 he married **Virginia Frances Kouns** (1842-1919) at Liberal Missouri. Amos B. Foote filed for an invalid pension in Indiana on 1 Nov 1889 (Application #736702 Certificate #478094) for service in Co C, 146th OVI. Virginia F. Foote filed for a widows' pension in Missouri on 15 Dec 1896 (Application #645028 Certificate #448877) They are both buried in the Barton City Cemetery in Liberal, Missouri.

Another Foote to serve from Warren County was their 1st cousin, **Douglass/Douglas M. Foote** (1829-1886). He was the youngest son of **Joseph Foote** (1791-1833) and **Rebecca "Phoebe" Foote** (1793-1876) and the grandson of **John Wesley Foote** (1766-1851) and **Mary Grigson** (1775-1819). Douglas M. Foote enlisted as a 33-year-old Private on 15 Aug 1862 and was mustered into Co L, 4th OVC on 15 Aug 1862. On 20 Aug 1864 he received a gunshot wound to his left elbow at Lovejoy Station, Georgia and received a disability discharge at Camp Dennison on 24 Jul 1865. Shortly after his discharge, he applied for an invalid pension on 25 May 1865 (Application #69358 Certificate #49159) for his service.

In 1871 Douglas Foote married **Jane King** (1836-1885) in Montgomery County. She was the widow of **Thomas Jefferson King** (1825-1857) and the daughter of **William A. Cameron** and **Elizabeth Sellers**.

Records of the U.S. National Homes for Disabled Volunteer Soldiers contain the following:

- Douglass M. Foote, Central Branch, Dayton, Ohio, Case #7181
- **Military History:** Enlisted April, 1861 at Franklin, Ohio in Co F, 1st OVI, discharged Jul 1861 at Columbus, Ohio. Reenlisted 15 Aug 1861 at Cincinnati, Ohio in Co L 4th OVC. gunshot wound in left elbow 20 Aug 1864, disability discharge at Camp Dennison on 24 Jul 1865.
- **Domestic History:** born Lebanon, Ohio, age 49, married shoemaker at Germantown Ohio, wife Jane of Germantown.
- **Home History:** Admitted 4 Oct 1877 discharged 10 Nov 1880 at his request. Readmitted unconditionally 27 Oct 1881 discharged 15 Aug 1884.

[Company F of the 1st OVI was organized by Captain John Kell at Franklin, Ohio in the month of April, 1861 as a 3 months unit and was known as the Franklin Greys. We did not locate any other records showing Douglass serving in the 1st OVI.]

Douglass is buried in the Germantown Union Cemetery in Montgomery County. Jane is buried in the King family lot at Lebanon Cemetery along with her first husband and two of their sons.

=> WAR OF 1812 PENSION FILES:

The digitization of War of 1812 pension files on fold3.com has resumed. This phase will cover surnames from "Moore through the letter Q. Pension files for men who served in Ohio Militia Units are now on line through the name **William Murray**. We noted three files with connections to Warren County: **John Mounts** ([17 images](#)), **William Mounts** ([20 images](#)) and **Aquilla Murphy** ([26 images](#)). We know of about 89 pension files containing 3,127 pages that have been digitized for soldiers with a connection to Warren County.

John Mounts ([17 images](#)) [War of 1812 Pension and Bounty Land Warrant Application Files](#)

Old War Widows' Pension File #11828 for **Rachel Willis.**, former widow of **John Mounts**.

John Mounts enlisted on 25 Jul 1818 as a Private, **Capt. Swearingen's** Company 26 Regiment US Infantry commanded by Col. **Thos. B. Van Horne**. **John Mounts** died while in the service on 27 Oct 1813. Rachel, his widow was awarded a 1/2 pay pension of \$3.50 per month for 6 years under the Act of 6 Apr 1816. Paid 7 Jan 1817, Voucher 3823.

On 11 Jul 1855, 83-year-old **Rachel Willis** of Butler County made a declaration before **Judge J. M. Smith**, Warren County Probate Court for the purpose of receiving a pension under the Acts of February 3, 1853 and August 5, 1854. She declared that she married her second husband **Daniel Perine** on 8 Jan 1818 in Butler County. He died in May of 1822. She then married her third husband, **William Willis** (2 Sep 1824 per Butler Co. Marriage Records) and she was again a widow at the time of her declaration. She stated that she had five children living at the time of William Willis' death: **Elizbeth Mounts**, **John Mounts**, **William Mounts**, **Delilah Mounts** and **Nancy Mounts**. **George Kesling** attested to her declaration which was also witnessed by **A. G. McBurney**. Rachel was awarded a pension of \$3.50 per month commencing 3 Feb 1853 and continuing for five years by Certificate No. 5561.

William Mounts ([20 images](#)) [War of 1812 Pension and Bounty Land Warrant Application Files](#)

Claim for Bounty Land under the Act of 1855 - (Application #203613 and 260391 - No Certificate Number)

On 24 Oct 1856 **William Mounts**, age about 68 years, of Warren County made a declaration before **William Dynes J.P.** for the purpose of obtaining bounty land under the Act of 1855. He said that he volunteered at Pickaway, Ohio in December 1812 for three months. He drove a horse team owned by the US government from Pickaway to Fort St. Marys under the direction of **Jabish Phillips**, wagon master. He then served at St. Marys under quartermaster **Col. Orr**. His deposition was witnessed by **Mathew Leonard** and **William Guttery**. He first filed through an agent, **Isaac Elston** of Mulberry, Clermont County, and later through **W. D. Wallace** of Morrow. In addition, his neighbor **John Hopkins** of Hopkinsville, wrote a letter to the pension office on his behalf on 22 May 1858.

On 4 Nov 1856 the Third Auditor office reported that **William Mounts** was paid for his services as a hired hand in the Quartermaster Department at St. Marys from 15 Feb 20 14 May, being three months at \$20 per month \$60.00. William's application was rejected.

Aquilla Murphy ([26 images](#)). [War of 1812 Pension and Bounty Land Warrant Application Files](#)

Aquilla was drafted at Lebanon on 5 May 1812 for six months a Private in Capt. Gilchrist's Company Ohio Militia in the regiment commanded by Col. **James Findley**. He was taken prisoner at Detroit on 16 Aug 1812 when Gen. Hull surrendered. He was taken to Cleveland by the British and afterwards was paroled and discharged on 5 Nov 1812. He was paid on the rolls for six months.

On 26 Oct 1850 **Aquilla Murphy**, age 59, of Warren County appeared before **Benjamin Blackburn J.P.** to make declaration for the purpose of obtaining Bounty Land under the Act of 1850. Fellow soldier, **George Zindle** witnessed his declaration. Bounty Land Warrant 1356 for 80 acres was issued under the Act of 1850 in favor of Aquilla Murphy on 4 Mar 1851 (Vol. 63 page 175). The warrant was not found in the General Land Office Records.

On 14 Mar 1855, **Aquilla Murphy**, aged 63, of Lebanon, appeared before **Benjamin Blackburn J.P.** to make a declaration for the purpose of obtaining Bounty Land under the Act of 1855. The declaration was witnessed by **Richard Cochran** and **L D. Blackburn**. He made a 2nd declaration on 18 May 1855 which was witnessed by **Joseph H. Evans** and **George Kesling**.

[Bounty Land Warrant 480](#) for 80 acres was issued under the Act of 1855 in favor of **Aquilla Murphy**, a private in Capt. Gilchrest's Company of Ohio Militia War of 1812. He assigned the warrant to **Elijah T. Currens** and **Simeon H. Walton** who were issued a patent for 80 acres in Marshall County, Iowa.

Aquilla Murphy and **Eleanor Spencer** were married at Lebanon on 18 Apr 1816 by **Enos Williams J.P.**

On 26 Apr 1878, **Eleanor Murphy**, age nearly 81 of Lebanon, Ohio gave a declaration before the Clerk of Courts for the purpose of obtaining a widows' pension under the Act of 1878. Aquilla was described as having black hair, blue eyes, fair complexion and about six feet tall. They lived in Lebanon after his service except for 10 years spent in Cincinnati. Aquilla died 29 Dec 1852. **George Bone** (age 36) and **Wm. C. Thompson** (age 29) witnessed her declaration. On 21 Sep 1878, **Marion D. Egbert** and **Ezra Cramer** of Lebanon, attested to their marriage and to her widowhood. Eleanor was awarded a pension of \$8 per month by certificate #9357 dated 26 Sep 1878. She was last paid \$8 to Dec 4, 1884 and dropped from the rolls due to her death on 28 Dec 1882.

Aquilla and Eleanor are buried in Old Section Lot 490 in the Lebanon Cemetery.
