### NATIONAL ARCHIVES PRICE INCREASE EFFECTIVE OCTOBER 1ST

The National Archives and Records Administration have made the announcement on their final decision on reproduction fee increases, effective 1 October 2007. If you've been thinking about ordering any pre-World War I Pension Files or Service Records, you might want to do so before this large price hike goes into effect.

- Complete pension file, up to 100 pages: \$75 (currently \$37). Pages in excess of 100 can be ordered at \$0.65 per page.
- Basic pension documents: \$25 (currently \$14.75).
- Military service records: \$25 (currently \$17).
