CHARLES CITY COUNTY [VIRGINIA] RECORD BOOK, 1692-1700

WCGS member, Terry Easton, contributed these recently found records thought to be lost since the Civil War and now returned to the Library of Virginia.

"A portion of the Charles City County Record Book, 1692-1700, taken from the Charles City courthouse in 1862 during the Peninsula Campaign of the Civil War, was returned to the Library of Virginia in 2016 by a Pennsylvania family who had cared for it for over three decades. It was reunited with another portion of the record book that had been returned to Virginia decades earlier. Record books summarize the matters brought before the county court and are an invaluable genealogical and historical resource. Deeds, wills, and estate inventories are the most common record types found in this volume."

PRIVATE AARON CARTER (____-1824) WAR OF 1812 PENSION FILE

War of 1812 Pension and Bounty Land Warrant Application Files, fold3.com, Aaron Carter (18 images)

Aaron Carter and **Sophia French** were married 12 Jul 1812 at Bradford County, PA. Aaron died at Millgrove, Warren County, Ohio on 4 Mar 1824. In a response to an 8 Mar 1883 request from the Pension Office. **S. D. Ludlum**, the Morrow, Ohio postmaster reported that Sophia had died about 7 years ago [ca. 1877]

Aaron Carter was drafted 2 Nov 1814 at Towanda, Bradford County, PA for a term of 6 months and served 23 days as a private in **Capt. Eliphalet Mason's** Company of Pennsylvania militia. He was honorably discharged at Danville, PA on 23 Nov 1814.

Bounty Land Warrant No. 64191 for 160 acres was issued in favor of **Sophia Carter** widow of **Aaron Carter**, Private, Captain Mason's Company Pennsylvania Militia War 1812. Sophia assigned the warrant to **Michael Riley** who was issued a patent on 16 Jul 1870 for 160 acres located in Pierce County, Wisconsin. The pension file did not contain any papers relating to her Bounty Land application.

On 11 Apr 1871, **Sophia Carter**, aged 75, of Salem Twp., Warren County, made a declaration before **William H. Rockhill**, Common Pleas Court Clerk, for the purpose of obtaining a widow's pension under the Act of 1871 (Application No. 2052). **George Beaty/Beatty** and **Amos Shawhan** gave testimony supporting her declaration. On 4 Jan 1872, Sophia's claim was rejected as Aaron did not serve at least 60 days as required by the Pension Act of 1871 (WO 2050).

CORPORAL JOSEPH BERRY (____-1859), CAPT. MARTINS CO. 27th US INFANTRY

The War of 1812 Pension Index Card for **Joseph Berry** states that he died in Warren County, Ohio. Papers in his pension file lists his burial location as Warren County, Iowa. After his death, his widow, **Margaret Rouse**, moved from Warren County, Iowa to Tama City, Tama County, Iowa and received a widow's pension under the Act of 1878 (WC 30622)

HIS PENSION FILE DOES NOT CONTAIN ANY RECORDS CONNECTING JOSEPH TO WARREN COUNTY, OHIO.
