Clues to Use

American State Papers

Our Warren County Genealogical Society Resource Library recently received a donation of nine volumes of the *American State Papers*. We also received the index – *Grassroots of America: A Computerized Index to the American State Papers, Land Grants and Claims* 1789-1834.

I found some interesting information in Volume 9 on page 235 headed, "Indemnity for Losses Sustained by the Insurgents in 1794." In 1794, George Washington called Neville to be the Inspector of Revenue and to collect the excise tax on distilled spirits. The result was the 1794 Whiskey Rebellion. John Neville's home, Bower Hill was burned, and an accounting was submitted to the government for payment for the losses. Included in this accounting was a very detailed list of items that were destroyed, from a two-story frame dwelling-house 40' long by 20' wide to a half a dozen silver tablespoons (two and a half pages of itemized items). If this were your ancestor, you would be thrilled to find this report! Have fun exploring these records.

American State Papers is the precursor to the *U.S. Congressional Serial Set*, containing the documents and reports of the U.S. Congress pre-1817. They can also be found online at https://memory.loc.gov/ammem/amlaw/lwsp.html.

The *American State Papers*, comprising a total of thirty-eight physical volumes, contain the legislative and executive documents of Congress during the period 1789 to 1838. The collection includes documents that cover the critical historical gap from 1789 to the printing of the first volume of the <u>U.S. Serial Set</u> in 1817. The books are arranged into ten topical classes or series:

I.	Foreign Relations	VI.	Naval Affairs
II.	Indian Affairs	VII.	Post Office Department
III.	Finances	VIII.	Public Lands
IV.	Commerce and Navigation	IX.	Claims
V.	Military Affairs	X.	Miscellaneous

The compilation, printing, and distribution of the *American State Papers* took place from 1831 to 1861 and the thirty-eight volumes contain 6,278 documents. Not all the classes contain documents from the entire 1789-1838 period. Every volume contains an index and all, but one has a table of contents, both with machine-searchable transcriptions.

HOWARD E. HUNT OBITUARY

"Died, at the residence of **Spencer Hunt**, near Red Lion, Warren county, Ohio, on the 9th of September, 1868, **Howard E. Hunt**, of consumption, in the 32d year of his age.

From a memorandum placed in our hands by a near and dear friend of the deceased, we learn the following particulars. He was left an orphan when quite a small boy and grew up in the care of his relatives. His life was one of activity and enterprise, attended with hardships and difficulties. Shortly after arriving at manhood, he went to Kansas, in the time of trouble there. He took with him money enough to place himself in a comfortable situation for life; but in consequence of the trouble in the ill-fated Territory, he lost the most of it and with his health impaired by exposure and privations, he left the place to better his condition elsewhere. He first went to the northern part of New Mexico; from there he went to Pike's Peak, where, in the month of August, 1858, he and some of his comrades, climbed to its highest point, some 12 or 15,000 feet above the level of the sea. At the summit they found snow from 3 to 6 inches deep. He remained in the mountains two or three years, in search of gold, but was unsuccessful. At the breaking out of the rebellion, he returned to his friends in Warren county, Ohio, and shortly after his return, he entered the army as a soldier in the 17th Independent Battery, Ohio Light Artillery, in which he served his country for three years. He was induced to enter the army for the double purpose of duty to his country and to punish the Missouri Border Ruffians and the South generally, for the injuries, cruelties and murders they had done in Kansas. Whilst in the army, he was in the following hard fought battles, besides many minor skirmishes, to-wit: The battle of Chickasaw Bayou, (near Haines' Bluff), from December 25th, 1862, to January 1st, 1863; Arkansas Post, (Fort Heneman) January 11th, 11863; Port Gibson, Mississippi, May 1st, 11863; Champion Hill, May 16th, 1863; Black River Bridge, May 17th, 1863; siege of Vicksburg from the 19th of May, till its capture on the 4th of July, 1863; siege and capture of Jackson, Mississippi, on the 17th of July, 1863; Grand Coleau, Louisiana, November 3d 1863. Here the Union army was defeated and routed; and here the subject of this memoir was closely pursued by the rebels, and would have been taken prisoner, had he not, at the time he must surrender, found a mule with bridle and saddle on; he mounted and made his escape. After this event he was at the battle of Fort Morgan, at the mouth of Mobile Bay, from the 16th to its capture of the Fort and the surrender of the city of Mobile, on the 9th of April, 1865; and on the 9th of August, 1865, the company was honorably mustered out of service. During all these hard fought battles the deceased had charge of the sighting and firing of a gun, and although thus exposed, he never received a wound. . . . "

Notes

From gravestone at Red Lion Cemetery "Howard E. Hunt, son of B. & M. J. Hunt, died Sept. 9, 1868, aged 31 ys. 8 mo. & 4 ds." His will signed 19 Aug 1868 lists **George W. Hunt** executor. Only heir listed was his sister, **Caroline "Carrie" H. Tilton**, wife of **Silas H. Tilton**.
