
WCGS WEBSITE UPDATE ACCESSING THE FULL CATALOG OF WCGS RESOURCE LIBRARY HOLDINGS

Did you know that you can search our library holdings from home? Thanks to our volunteers, Don Simons in particular, ALL of the items in our library have been entered in our LibraryThing account and can be searched by title, author, or subject.

<u>LibraryThing</u> is an online service to help people catalog their books easily. You can use the app on your desktop computer or mobile device, and it helps you keep track of what is in your library. While this is a very simple explanation, it is capable of much, much more, and for small libraries, there is an extra bonus. TinyCat is an online catalog solution for "tiny" libraries (with less than 20,000 items) that use LibraryThing to catalog their collections. And our TinyCat connects to our website so YOU can see what we have in the library!

CORPORAL WILLIAM JACKSON WAR OF 1812 BOUNTY LAND APPLICATION

Charlene Frey, a direct descendant of William Jackson (1777-1857), provided us with a copy of his Bounty Land Application File (11 pages) which she obtained from the National Archives. The following is extracted from that file and from the Bureau of Land Management General Land Office files for the land patents resulting from the warrants issued to him for his service.

Muster Rolls and Payroll Cards indicate that **William Jackson** served from 16 Sep 1812 to 29 Mar 1813 as a Corporal in Captain **John McWhorters** Company in the 1st regiment of Virginia militia commanded by **Colonel Connell**.

On 20 Dec 1850 **William Jackson**, aged 73, a resident of Warren County made a declaration before **William McFenan**, a Justice of the Peace, for the purpose of obtaining bounty land under the Act of 28 Sep 1850. He said he was a corporal in the company commanded by Captain **John McWhorter** in the regiment of infantry commanded by Colonel McConnell. He volunteered at Lost Creek Harrison County Virginia on or about the month of May or June 1812 for the term of six months and continued in service for six months and was honorably discharged at the rapids of the Maumee river on or about the month of March 1813.

Bounty Land Warrant No. 30,163 for 80 acres was issued in favor of **William Jackson**, Corporal in Captain **McWhiters** Company Virginia Militia War of 1812. He assigned the Warrant to John Stailey who was issued a patent on 1 Sep 1852 for 80 acres in Starke County, Indiana.

On 24 Mar 1855, **William Jackson** aged 78, a resident of Warren County, made a declaration before **James D. Wallace**, mayor of the village of Morrow for the purpose of obtaining bounty land to which he may be entitled under the Act of 3 March 1855. He declared that he was the **William Jackson** who was a corporal in the company commanded by Captain McWhorter in the regiment of Virginia milia commanded by Colonel McConnell in the War of 1812. He volunteered in Clarksburg at Harrison Co. Virginia about the month of July 1812 for the term of six months and continued in actual service in said war for the term of eight months and was honorably discharged at the Maumee Rapids in the month March 1813.

His declaration was witnessed by William Ireland and G. W. Starkey, both citizens of Warren County.

Bounty Land Warrant No. 1924 for 80 acres was issued in favor of **William Jackson**, Corporal in Captain McWhorters' Company of Virginia Militia War of 1812. He assigned the warrant to **Samuel Dill**, **Robert L. Dill** and **Say Brook Lee** who obtained a patent on 26 Feb 1857 for 80 acres in Guthrie County, Iowa. https://glorecords.blm.gov/details/patent/default.aspx?accession=0014-479&docClass=MW&sid=h4kfcfbn.aog

The following is from a biographical sketch for William Ireland on page 1024 of Beer's History of Warren County,

"William Jackson, the father of Mrs. Ireland [Jemima Jackson], a native of New Jersey, born about 1777. He went to Virginia when quite young; he married Miss Hannah Bennet, a native of Maryland, born Dec. 25, 1779. They came to this state in 1828; they were the Parents of eleven children, among whom was the Rev. W. B. Jackson, of the Cincinnati Conference."

William Jackson and his wife are buried in the Wesley Chapel Cemetery in Harlan Township.
