NECROLOGY: NANCY "ANNE" (nee Walker) FRITZ (4 Jul 1941-27 Aug 2015)

The Warren County Genealogical Society has lost another longtime member with the passing of **Anne Fritz**. Nancy was a third great granddaughter of <u>Samuel Brice Walker</u> (1779-1845) who bought a 1000 acre parcel of land in Hamilton Township and settled here in 1802. Nancy and other family members still own portions of the original parcel. Nancy was a lifelong member of the Murdoch Presbyterian Church which was founded in 1825 by Samuel Walker and a dozen other pioneer settlers. Anne was buried in the <u>Hopkinsville Cemetery</u> alongside her husband Karl.

OUR IRISH FAMILIES presented by Harriet Foley

Wednesday, 21 Oct 2015 at 7:30 PM in the Phillippi Meeting Room, the Campus Center at the Otterbein Retirement Community, 585 N State Rte. 741 (north of Rte. 63), Lebanon.

Harriet will tell how she and Tom have researched their Irish families who came over in 1773, 1815, the 1850s and the 1960s. They have gone to Ireland over 14 times and met and dined with cousins, seen family houses, businesses, tombstones, and the Loophead Lighthouse.

She will bring a notebook of letters from 1848 to 1900, their Foley book and outlines, some photos, and other items.

Harriet Foley is a native of Warren County living in Franklin. She is a retired Carlisle School librarian who has been active for many years with the Franklin Area Historical Society, Daughters of the American Revolution and the Warren County Genealogical Society. Harriet has done extensive genealogical research both in the United States and Ireland and was the editor of the following books;

THOMAS LUCAS (1730-after 1823) – WILL DATED 17 Feb 1820

In the name of God amen. I <u>Thomas Lucas</u> of the State of Ohio Warren County considering the uncertainty of this mortal life and being of sound and perfect mind and memory blessed be the almighty God for the same do make and publish this my last will and testament in manner and form following first I want all my just debt and funeral paid and do give my wife **Mary Lucas** her maintainance as long as she remains my widow to be paid to her yearly and all her Removeables which she brought to me in sted of her dowry. I do also give to my son **Abraham Lucas** & my son **John Lucas** & my son **Ebenezar Lucas** & my son **Caleb Lucas** and my son **Francis Lucas** all my lands and tenements to be equally divided for them. I also give to my daughter **Massee** ten dollars I also give to my daughter **Rhoda Phillips** ten dollars I also give to my daughter **Sarah Ulrey** ten dollars to be paid to them within eighteen months after my Decease I hereby appoint my son **Caleb Lucas** and my son **Francis Lucas** Executors of this my last will and testament and for them to sell or divide the land when they see proper. Here by revoking all former wills by me made in witness there of I have here unto set my hand and seal this 17 day of February in the year of our lord one thousand eight hundred and twenty 1820

NOTES:

This will is not filed or indexed with other Warren County Probate Records and does not appear to have been entered into Probate. Mary is possibly a 2nd wife and not necessarily the mother of the listed children. She did not sign a release of Dower when Thomas sold his land to Francis Lucas. See also

WAR OF 1812 PENSION DIGITIZATION PROJECT

Based on the pension files that we have found so far, we are guessing that there will be about 136 pension files with a total of about 5,000 pages that have a connection to Warren County. The cost to digitize those pages will be about \$2,250.

We are entering the last two months of our fundraising project. Thanks to the wonderful response that we have had so far, we are confident that our fund raising effort will be sufficient to cover the cost of all of "our Warren County files." Final results will be announced at our December Board meeting.s

FIRST FAMILIES OF OHIO #455 RAYMOND ELLSWORTH SUTTON

The Ohio Genealogical Society Quarterly has an ongoing series of articles by Kay Ballantyne Hudson which provides an abstract of early First Family files. FFO #455 proved 10 ancestors of **Raymond Ellsworth Sutton** who resided in Ohio by the end of 1820 including the following which were proven to be in Warren County.

- No. 1502. **Jacob Baker** (1780-1821) in Warren County by 1809 buried <u>Baker Cemetery</u> his wife, No. 1505 **Nancy Mounts** (ca. 1790-1870) in Warren County by 1809
- No. 1504 William Mounts (d. before 1808) in Warren County by 1795 buried Mounts Cemetery his wife, No. _____ Catherine E. Watson (d. before 1818) in Warren County by 1795 buried Mounts Cemetery
- No. 1500 **Tobias Bretney** (1760-1853) in Warren County by 1814 buried at <u>Lebanon Cemetery</u> his wife, No. **Nancy Butler** (ca. 1772-1846) buried at <u>Lebanon Cemetery</u>
- No. 1501 William Bretney (1808-1866) born Warren County 1808 his wife, No. 1503 Elizabeth Baker (1811-1883) – born Warren County 1811

William F Roser appearing in open court & being sworn saith that he is a native citizen of the Kingdom of Wurtemburgh that he came to these United States in the year 1817. That it is bona fide his intention to become a citizen of these United States & to renounce forever all allegiance & fidelity to any foreign prince potentate State or Sovereignty whatever & particularly the [...] King of Wurtemburgh
